# **Earlier versions of** psychoanalytic

thought and of cognitive-behavioral therapy were formulated in ways that presented serious obstacles to meaningful, coherent integration; newer versions provide opportunity for synergistic and logically consistent combinations. These new developments in each approach are often only sketchily understood by proponents of the "other" orientation, leading to continued caricaturing of each other and, even more important, to missed opportunities for more effective clinical work. The conference is aimed at practitioners of all orientations, and seeks to provide each with a better understanding of other approaches to clinical work and a better conceptual foundation for integrating cognitivebehavioral and psychodynamic approaches.

## **Morning Session**

Dr. Wachtel will invite his audience to consider how the evolution of the relational point of view in psychoanalysis and of constructivist and acceptancefocused forms of cognitive-behavioral therapy enables the knowledgeable therapist to bring to bear the differing strengths of each approach in a way that does not violate the central assumptions of either and that offers patients a more comprehensive and deeply experiential therapy.

## **Afternoon Session**

Dr. Wachtel will describe how therapeutic possibilities can be expanded by integrating understanding of different approaches. He will highlight, among other themes, how psychoanalytic interpretations can be enhanced by understanding the ways that they incorporate elements of what cognitive-behavioral therapists refer to as exposure, and how the recognition of this overlap can enable the analytic therapist to frame interpretations that are more clinically effective. Dr. Wachtel will emphasize a range of ways in which therapists may unwittingly couch "accurate" comments about the patient's dynamics in ways that are clinically counterproductive and how relatively small changes in the ways we phrase our comments to patients and conceptualize the nature of the problematic patterns we are addressing can have a large impact on the success or failure of the therapeutic effort. Clinical case examples will be shared to illustrate Dr. Wachtel's "cyclical psychodynamics" approach to treatment and invite audience discussion.

## Paul L. Wachtel. Ph.D. is CUNY

Distinguished Professor in the doctoral program in clinical psychology at City College and the CUNY Graduate Center. He is the author, among many books, of Psychoanalysis, Behavior Therapy, and the Relational World (1997): Relational Theory and the Practice of Psychotherapy (2008); and Therapeutic Communication (2011). He has been selected for the Hans H. Strupp Award for Psychoanalytic Writing, Teaching, and Research, the Distinguished Psychologist award of Division 29 (Psychotherapy) of APA and the Scholarship and Research Award by Division 39 (Psychoanalysis) of APA.
